
To end this column, I have decided in 1 millionth of a second to have a plate of plain old-fashioned vanilla ice cream. Please join me.

THE OBERHOLTZER BOOK CORRECTIONS/ADDITIONS

Tony Bennyhoff of Shoemakersville PA, a descendant of Cornelia Appenzeller (HJ2421), wrote to say that it was Eleanor Savacool, not Elizabeth (HJ24), who married Jacob Appenzeller. He said that Bucks Co Orphans Court records show that Elizabeth Oberholtzer Savacool (HJ2) probably died in 1815. Henry Appenzeller (HJ242) never married Elizabeth Benner and left the area by the time of or soon after Cornelia's birth. In 1812 he was married to Mary Foster and living in Franklin Co PA. In 1850 he was living in Ross Twp. Butler Co OH with son John who appears in Burlington, Carroll Co IN 1860. John married Catherine Eliza Shirey 1/21/1836. (Jacob Oberholtzer of Hatfield Twp, Montgomery Co line)

Isaac Overholser (SL278) married the second time Mary Spatts who married, after his death, Rev Jacob Zern. A marriage certificate shows that Frau Marie Overholser was married 5/8/1883 by W C Kantner to Rev Jacob Zern. Witnesses at the marriage were Levi & Lydia Watts. (Isaac was s/o Martin & Elizabeth (Frantz) Oberholtzer of Terre Hill, Lancaster Co PA)

MARTIN OVERHOLT 1743 Bucks Co-1811 WESTMORELAND CO PA (MC75) S/O MARTIN OBERHOLTZER & AGNES KOLB

On page 132 of A GENEALOGICAL RECORD OF THE DESCENDANTS OF MARTIN OBERHOLTZER, Rev A J Fretz said "It is said that in the time of the Revolution, not being friendly to the war and being loyal to the King, that he (Martin Overholt) with others of the family went to Canada, but not liking the climate he returned and emigrated to Western Pennsylvania". I find it very interesting that quite a few people interpreted this paragraph in different ways. Some have said that Martin went to Canada for the duration of the war while his wife and family managed the farm. Another account is that he took his family to Canada where a son was born 1777 and a daughter in 1779. If Martin left his family behind, how is it that he had children born during the war. His oldest child would have been 5 in 1775 so I doubt that she would have been much help in managing a farm. If he had taken his family along, his property would no doubt have been confiscated by the Pennsylvania government. Beginning in May 1778, the Pennsylvania government passed a series of proclamations listing the names of individuals believed to be with the enemy. John Overholt (JT) of Tinicum Twp, Bucks Co had his 235 acres confiscated 1781 and John Reid of Tinicum Twp had his 1409 acres taken in 1782.(1)

Stanley W Nash of Vancouver, British Columbia, Canada believes that Rev Fretz' story is partially true. He feels that Martin may have gone to Canada in April 1786 with two second cousins Jacob and Tilman Culb in a caravan with Staats Overholt, Frederick Haun and their families. (The first group of Mennonites known to have settled in Canada were these families.[2]) He doubts that Martin went during the Revolution because the Iroquois of up-state and western New York were allies of the British crown. Unidentified stranger colonists, expecially a party of them, even if loyal to the British king, would risk an unfriendly reception by the Indians. In 1779 American revolutionary forces broke the power of the Iroquois, causing much devastation. Would-be emigrants to Canada would have had to evade American soldiers stationed there.

An article by Anne M Ousterhout said "To the individual dissenter whose flight from the State in opposition to its new government meant the loss of all his property, confiscation was a very tragic and revolutionary occurrence".(3)

In 1775 and 1779 two Martin Overholts are listed on the tax list for Tinicum Twp, Bucks Co. The other Martin is c1745-1817 Plumstead Twp, Bucks Co (MT3) who appears to have moved to Bedminster Twp 1781 and in 1785 to Plumstead Twp.

Martin Overholt (1743-1811) bought land in Tinicum Twp in 1770 and 1782.(4) He and his wife Esther Fretz sold their

land 4/20/1795 (5) and their next transaction is in Westmoreland Co when they purchased 395+ acres on 5/28/1796.(6) George Washington declared the war at an end on 4/19/1783 but Martin & Esther didn't go to Westmoreland Co until 1795/6.

John L Overholt of Kilmarnock VA joined the SAR through Martin Overholt (MT3) saying that he was in Capt Patterson's Tinicum Twp company in the Revolution. This Martin married Elizabeth Nash who was a half-sister of Martin Overholt (MC75). BUCKS COUNTY SOLDIERS IN THE REVOLUTION by Williams & Williams lists a Martin Overholt in 1780 with exercise fines in Tinicum Twp.(7) Which Martin was this? I decided to check the reference in the Pennsylvania Archives and I found that there were actually two Martin Overholts who had exercise fines for April and May 1780.(8) This shows both Martins were in Capt Patterson's company at that time and each was fined &72 for failing to appear for drill.

Martin Overholt (MC75) had a brother Henry (MC72) [my ancestor] who was listed in Bedminster Twp, Bucks Co in 1780, 1781 & 1782 with exercise fines. One source said that he served throughout the Revolutionary War which, of course, is not true.

The Martin Overholt/Esther Fretz home in Tinicum Twp, Bucks Co is still standing. According to John L Overholt, the home was dated by the architects from Independence Hall as being built before 1750, with additions having been made.

I would appreciate hearing from members in the Martin Overholt/Esther Fretz line about their thoughts on Martin's trip to Canada. Was this another "family tradition"?

HALBERT'S UNDER CEASE AND DESIST ORDER

The National Genealogical Society Newsletter Vol 22 #2
March/April 1996 reports that on 11/21/1995, the U.S. Postal
Service issued a supplemental cease and desist order
prohibiting Halbert's from further use of certain misleading
marketing practices, which included a consent agreement
signed by Halbert's. Previous cease and desist orders issued
against Halbert's in 1985 and 1988 remain in effect.

The supplemental order issued in November 1995 includes

the following provisions:

*Halbert's was ordered to cease and desist from falsely representing "...that (1) a solicitation for a surname-related product was sent by a relative of the solicitee; (2) a relative of a solicitee was involved in preparing a surname-related publication; or that (3) a relative of a solicitee endorses a surname-related product." The Postal Service contended that the company's solicitations, which advertised books such as THE WORLD BOOK OF (surname) and THE (surname) SINCE THE CIVIL WAR, violated the 1988 consent agreement, because they appeared to be letters from relatives of the addressees urging them to purchase a recently completed book on their family.

*Halbert's was ordered to begin displaying prominently the following disclaimer on any advertising for surname-related publications: "No direct genealogical connection to

your family or ancestry is implied or intended."

*Halbert's was ordered to cease and desist from "...representing, directly or indirectly, that advertising has been approved by the United States Postal Service."

Under the 1988 cease and desist order, the following con-

duct by Halbert's is prohibited:

*Representing that a book is principally about a particular family name and the history of this family name
*Representing that a book contains information about
someone's forebears and their emigration from Europe

*Representing that a book contains information about the heraldry and family crest of a particular family.

*Representing that a book explains how a particular family got its surname.

*Representing that a book explains why someone's forebears immigrated to the New World (U.S., Canada & Australia)

*Representing that a book explains why persons with a particular surname immigrated to the New World.

*Representing that a book is the result of research through numerous sources by themselves, or someone acting in their behalf, to compile information on persons with the addressee's surname who immigrated to the New World.

DR G H OVERHOLT OF KENYON, MINNESOTA

Barbara Roadhouse of Nanticoke, Ontario, Canada sent the 1928 obituary of Dr G H Overholt of Kenyon MN, s/o Mark Overholt (MT27) & Catharine Gilmore and a grandson of Staats Overholt. When Dr Overholt lived in Madelia MN in 1876, the Jesse James & Younger Brothers gang was operating in the area. The Younger brothers came to the doctor's drugstore for medical aid which he gave them. Cole Younger purchased a pint of whiskey from Overholt who made him promise to use it for medical purposes only and not become intoxicated. The next day the gang was suspected of being the Northfield bank robbers and a posse, joined by Dr Overholt, set out to capture the bandits. Dr Overholt was struck by a bandit's bullet, but his life was saved when the bullet hit a heavy watch charm he wore, and glanced off. Jesse and Frank James escaped but the Younger Brothers were forced to surrender. Cole Younger told the doctor "Well Doctor, we didn't get drunk on your whiskey." The doctor then administered first aid to the wounded bandits.

FINDING A CEMETERY

Helen Shonk of Dover OH wrote Pat Curtis of Bull Shoals AR that she had found the cemetery where Esther Overholt, wife of Martin (MC75) is buried along with Matthias and Barbara Burchfield (MC754). The cemetery is in the middle of a horse pasture with stones lying on the ground. The owner said he would maintain it if Helen and her husband wanted to clean up the stones. They planned to go when the weather was nice with a pitchfork and a bucket of suds and do some probing. It is called Sink Cemetery on the former Burchfield farm, Franklin Twp., Tuscarawas Co OH.

A 1756 OBERHOLTZER ORIGINAL DEED

The Mennonite Historians of Eastern PA in Harleysville has received an original parchment deed which was recorded in Philadelphia Deed Book H12/359 10/22/1761. The deed was signed 7/30/1756 by the children of Immigrant Jacob Oberholtzer of Franconia Twp, Philadelphia Co (now Montgomery Co) who granted their share of his 185 acres of land to their brother Jacob for &330. Matthias Stouffer of Conestoga Twp, Lancaster Co and wife Anna signed with their marks, as did Barbara Funk of Franconia Twp. Jacob Oberholtzer Jr of Franconia Twp and Jacob Hackman of Franconia Twp signed their names and Elizabeth Hackman signed with her mark. This 238 year old deed is in good condition and I was able to have a copy made.

WHO IS THIS WILLIAM OVERHOLTZ?

William Overholtz, c1825-8/26/1888 Flora IN, married 11/2/1880 Carroll Co IN, Martha J Wikle c1861-12/26/1887. Their children were-Sarah born 9/25/1881, Effie 12/22/1882-6/1/1888, George born 7/21/1884, John born 12/15/1885 and Jennie 12/26/1887-7/19/1888. Martha Overholtz died in childbirth and William died of a disability received when he was in the 99th IN Regiment, Co F while serving in the Civil War. He enlisted 8/22/1862 and was discharged 6/5/1865. On 1/18/1888 he applied for an increase of his \$6.00 a month pension saying that at age 63 his disability prevented him from working as a laborer and that, due to his wife's death, he had to care for his 5 children. Effie died in the Soldiers Orphans Home, Knightstown, Rush Co IN and Jennie died in Flora IN. In trying to trace the remaining children in 1900, I found John was an inmate in the Soldiers Orphans Home in Rush Co, George was a servant of Stephen Harlan Jr in Hancock Co IN and Sarah was a servant of John H Prewett in Pulaski Co IN. In the 1910 Census, I think I found George in Champaign Co IL married to a Mary and John, I believe, was single in Cook Co IL. In 1850 Somers Twp, Preble Co OH, there was a William age 24 with David (AV2) and Mary Overholts and I believe that he was David's son. I think that possibly the William Overholtz c1825-1888 was the s/o David. If he is, he would have had cousins living in the area of Flora, Carroll Co IN. David Heckman (AV13) is buried in Flora Cemetery and so is William Overholtz. If a member of the Association has a listing for the Flora Cemetery, Monroe Twp, Carroll Co IN, the location of William's grave might give us a clue as to who his relatives were.

When Samuel Oberholtzer told his mother Elizabeth of his intention to go to Ohio, she exclaimed "Oh! Are you going to Ohio? It wouldn't be so bad if you would only stay in America."

(Samuel [SL277], who died c1836 IL, was the s/o Martin & Elizabeth (Frantz) Oberholtzer of Terre Hill, Lancaster Co and great grandson of 1727 Immigrant Samuel Oberholtzer)
